Pre-Apprentices

Effective June 5, 2017, Employers signatory to the Collective Bargaining Agreement between the NCSRCC & AGC or ACEA (for work performed in the jurisdiction of the Wisconsin Local Unions listed at bottom of page), will not pay the DB Pension contribution for the pre-apprentice's first 730 hours. The required contribution for the DC Pension for pre-apprentices is reduced to \$1.00 for the first 730 hours. Existing pre-apprentices are grandfathered in at full benefits. Any pre-apprentice hired on or after June 5, 2017 falls under this new rule. Please be sure to put them on a new separate remittance report since they will have different fringes due on their behalf. Log onto our website at www.ncscbf.com to obtain a blank remittance report for setting up new pre-apprentices. Once you have filed an initial report for the new pre-apprentices, the Fund Office will send you a pre-printed remittance report each month thereafter.

Piledrivers

Effective June 5, 2017, Employers signatory to the Collective Bargaining Agreement between the NCSRCC & AGC or ACEA (for work performed in the jurisdiction of the Wisconsin Local Unions listed at bottom of page), will pay a different rate for the DC Pension Fund (Supplemental Retirement Fund) for Piledrivers than they will for Carpenters. If you employ Piledrivers, the hourly fringe rate will be \$2.56 vs. \$2.55 for Carpenters. Please log onto our website at www.ncscbf.com to obtain a blank remittance report so that you can list the Piledriver employees separately. Once you have filed an initial separate report for Piledriver employees, the Fund Office will send you a pre-printed remittance report each month thereafter.
