This is a summary of the annual report for the NORTH CENTRAL STATES REGIONAL COUNCIL OF CARPENTERS' HEALTH FUND, (Employer Identification No. 39-6069788, Plan No. 501) for the period January 1, 2021 to December 31, 2021. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

INSURANCE INFORMATION

The plan has contracts with HHC Life Insurance Company to pay organ and tissue transplant claims incurred, Sierra Health and Life Insurance to pay retiree medical claims incurred by those covered by Medicare, HCC Life Insurance Company to pay stop loss claims incurred, and Care-Plus Dental for dental claims incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2021 were \$6,900,223.

BASIC FINANCIAL STATEMENT

The value of Plan assets, after subtracting liabilities of the Plan, was \$154,930,955 as of December 31, 2021 compared to \$157,498,914 as of January 1, 2021. During the Plan year, the Plan experienced a loss in its net assets of \$2,567,959. This decrease includes unrealized appreciation or depreciation in the value of Plan assets; that is, the difference between the value of the Plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the Plan year, the Plan had total income of \$78,515,114. This income included employer contributions of \$62,062,384, employee contributions of \$8,736,979, realized gain of \$742,530 from the sale of assets, gain on investments of \$6,924,678¹ and other income of \$48,543. Plan expenses were \$81,083,073. These expenses included \$2,699,661 in administrative expenses and \$78,383,412 in benefits paid to participants and beneficiaries.
